5. The applicant further acknowledges that the data provided is for the purpose of pedigree research of assistance to breeders of the breed of dog and is done so upon the following express agreement;
  - a. The licence to use the data provided is none exclusive and non-transferable with the import and effect that the data must not be used for any other purposes or in any manner other than is agreed herein;
  - b. The data must not be used for any commercial purpose nor shall it be used for or in conjunction with a registry of dogs whether that be of pedigree dogs or otherwise;
  - c. The data provided must be used in the form provided without alteration;
  - d. The data must not be used in any way that could damage the reputation of the provider or the good will or other rights associated with the data;
  - e. The licence to use the data is determinable at the will of the provider revocable at any time by the provider in its absolute discretion;
  - f. Nothing in this Agreement for licence will constitute a transfer of any intellectual property rights in the data and the data that is provided is upon the express acknowledgement that the ANKC owns all intellectual property rights in the data and the applicant will not directly or indirectly do anything that would or might invalidate or put in dispute ANKC's title in the data.
